**ARTICLES OF ORGANIZATION
OF CLEAR VISION MANAGEMENT, LLC
A FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE 1: NAME

The name of the limited liability company ("LLC") shall be CLEAR VISION MANAGEMENT, LLC.

ARTICLE 2: PURPOSE

The LLC may engage in any lawful business not prohibited by statute or law.

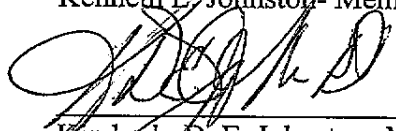
ARTICLE 11: CERTIFICATES
