



ARTICLES OF ORGANIZATION

of

1501 VENERA, L.L.C.

a Florida Limited Liability Company

THE UNDERSIGNED, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, adopts the following Articles of Organization:

ARTICLE ONE Name and address

The name of the company is 1501 VENERA, L.L.C. and the street address of the principal office of the company and the mailing address of the Company shall be: 360 Greco Avenue, Strite 208, Coral Gables, Florida 33146.

ARTICLE EIGHT Voting

Except as otherwise provided in regulations adopted by, and any written agreement entered into by the members, with respect to any matter requiring a vote of the members, each member shall have one vote for each one (1%) percent interest in the Company.

ARTICLE NINE Regulations

Except as otherwise provided in regulations adopted by, and any written agreement entered into by the members, the members may, from time to time, by majority vote, adopt, after, amend or repeal regulations for the Company.


