

**ARTICLES OF ORGANIZATION OF DAVIS & HUTSON  
LIMITED LIABILITY COMPANY**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I — Name:**

The name of the limited liability company (hereinafter referred to as the "Company") is "Davis & Hutson, LLC".

**ARTICLE II — Address of LLC and Registered Agent:**

2.1 **Principal Office.** The mailing address and street address of the principal office of the Limited Liability Company is 1110 NW 6<sup>th</sup> Street, Gainesville, Florida 32601.

2.2 **Relocation.** The Members may from time to time move the principal office to any other address in Florida.

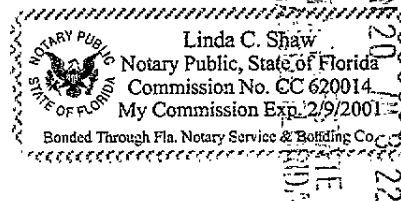
