CERTIFICATE OF CONVERSION

Pursuant to Florida Statute §608.439, the following unincorporated business entity hereby submits the attached Articles of Organization and this certificate of conversion to convert to a Florida limited liability company:

ARTICLE I – FORMER NAME

The unincorporated business immediately prior to filing this document was an informal partnership under Florida Statute §620.8202, operated under the names of its partners T. Boyd Moody and David Youngblood, and had no partnership name.

ARTICLE II – DATE & JURISDICTION

The unincorporated business was created or came into being on September 1, 1997, in Duval County, Florida.

ARTICLE III – CURRENT NAME

The name of the limited liability company as set forth in the attached articles of organization is MOYO, L.L.C.

ARTICLE IV – EFFECTIVE DATE

This certificate of conversion shall be effective when filed with the Florida Department of State.

**ARTICLES OF ORGANIZATION
OF
MOYO, L.L.C.**

The undersigned organizer, who is the authorized representative of the members of MOYO, L.L.C. (the "Company") under the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization.

ARTICLE I - NAME

The name of the Company is MOYO, L.L.C.

ARTICLE II - DURATION

The period of duration of the Company shall be until December 31, 2030, unless terminated sooner pursuant to the Company's Regulations.

ARTICLE III - PRINCIPAL OFFICE

The principal place of business and mailing address of the Company is 4652 Philips Highway, Jacksonville, Florida 32207.

ARTICLE IV - INITIAL REGISTERED AGENT AND ADDRESS

The name and street address of the initial registered agent are Dennis L. Blackburn, Suite 200, Southpoint Building, 6620 Southpoint Drive, South, Jacksonville, Florida 32216.

ARTICLE V - INITIAL MEMBERS

The initial members of the Company shall be T. Boyd Moody and David Youngblood.

ARTICLE VI - ADDITIONAL MEMBERS

The members shall be entitled to admit additional members upon the consent of the Company's Managers. Following the consent of the Managers, any prospective member shall become a member upon payment of his, her or its contribution to the capital of the Company and upon such prospective member's agreement to comply with the Articles of Organization and Regulations of the Company.

ARTICLE VII - DISSOLUTION OF COMPANY

The death, retirement, resignation, expulsion, bankruptcy or dissolution of a member shall terminate the membership of that member in the Company. Upon the occurrence of any such event or any other that terminates the continued membership of a member in the Company, the

Company shall be dissolved unless all of the remaining members consent to continue the existence of the Company.

ARTICLE VIII - MANAGEMENT

The management of the Company shall be vested in a Board of Managers as set forth in the Company's Regulations. The name and address of the initial members of the Board of Managers, who shall serve as the Managers of the Company until their successors are elected and qualified, are:

ARTICLE IX - RETURN OF CAPITAL

No member shall have the right to the return of his, her or its contribution to capital except as provided in the Company's Regulations.


ARTICLE X - AMENDMENT OF ARTICLES OF ORGANIZATION

ARTICLE XI - REGULATIONS

Regulations of this Company shall be approved and adopted by majority vote of the members of the Company and may be amended by a majority vote of the members of the Company.
