#### ARTICLES OF ORGANIZATION OF PRINCE & FIELDS, P.L.

The undersigned, being the Members and Organizers of the Professional Limited Liability Company hereby being formed under the Florida Statutes Annotated Chapter 621, do hereby adopt the following Articles of Organization for the Professional Limited Liability Company

FIRST: The name of the Professional Limited Liability Company is:

#### PRINCE & FIELDS, P.L.

SECOND: The latest date on which the Professional Limited Liability Company is to dissolve is January 21, 2024.

THIRD: The Professional Limited Liability Company is organized to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a professional limited liability company may be organized in accordance with the Florida Statute Chapter 621, including all powers and purposes now and hereafter permitted by law to a professional limited liability company. Specifically, this professional limited liability company shall render the professional services commonly associated with a law firm.
