ARTICLE I — Name:

The name of the limited liability company (hereinafter referred to as the "Company") is "P.I.G. Of Naples, LLC"

ARTICLE II — Address:


The mailing address and street address of the principal office of the Limited Liability Company is 950 Central Avenue, Naples, FL 34102.

The right, if given, of the remaining members of the limited liability company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall be governed by the Regulations.

ARTICLE VIII — Limitation on Agency Authority of Members

Pursuant to Section 608.424 of the Florida Limited Liability Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.
