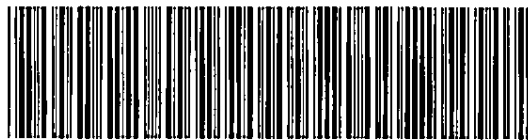

ARTICLE I – Name; Original Date of Filing

The name of the Limited Liability Company is **FACC Services Group, L.L.C.** (the “Company”). The Company was established pursuant to Articles of Organization filed on June 28, 2000 in accordance with the Articles of Merger, filed on the same date, with the Florida Secretary of State’s office.

ARTICLE II - Address

The mailing address and street address of the principal office of the Company is 3544 Maclay Blvd., Tallahassee, Florida, 32312.

ARTICLE III – Member Managed

The Company shall be managed by the Florida Association of Court Clerks and Comptrollers, Inc., a Florida not-for-profit corporation, its sole Member, and the Company is therefore a member -managed Company.

ARTICLE IV- Duration

The Company shall exist perpetually, unless sooner dissolved in accordance with the Company’s Regulations, Operating Agreement, or Florida law.

ARTICLE V- Registered Agent and Office

The street address of the Company’s initial registered agent and office is 101 East College Avenue, Tallahassee, Florida 32301, and the name of its registered agent at such office is Fred W. Baggett.

ARTICLE VI - Membership Units

There shall be only one (1) authorized Membership Unit in the Company, which is held by its sole Member, the Florida Association of Court Clerks and Comptrollers, Inc.

ARTICLE VII – Purpose

The primary purpose of the Company shall be to engage, directly or indirectly, in any and all types of lawful business for which limited liability companies may be

organized under the Florida Revised Limited Liability Company Act (Chapter 605, Florida Statutes).

ARTICLE VIII – Amendment Of Articles Of Organization

The Company reserves the right to amend or repeal any provision contained in these Articles of Organization by a vote of the Florida Association of Court Clerks and Comptrollers, Inc., the sole Member of the Company.

ARTICLE IX –Amendment And Restatement

These Amended and Restated Articles of Organization have been duly authorized and directed by an affirmative vote of the Florida Association of Court Clerks and Comptrollers, Inc., the sole Member of the Company, on June 17, 2020 which Member's consent was sufficient for the approval of the Amended and Restated Articles of Organization. Such Amended and Restated Articles of Organization supersede the original Articles of Organization of the Company.
