ARTICLES OF ORGANIZATION
of
TRON TECH OF PENSACOLA, LLC

The undersigned subscriber to these Articles of Organization, desiring to form a limited liability company pursuant to the Florida Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, and being a natural person competent to contract, hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a professional limited liability company under the laws of the State of Florida.

ARTICLE I (NAME)

The name of this limited liability company is TRON TECH OF PENSACOLA, LLC (the "Company").

ARTICLE II (DURATION)

The Company shall have perpetual duration, beginning on the date these Articles of Organization are filed in the Office of the Secretary of State of the State of Florida.

ARTICLE III (PURPOSE)

Except as limited by Chapter 621 of the Florida Statutes, the Company shall have all of the powers stated in the Florida Limited Liability Company Act, Chapter 608, the Florida Statutes, as such chapter presently exists and may hereafter be amended, and to render professional medical services.

ARTICLE IV (PRINCIPAL OFFICE AND REGISTERED AGENT)

The street address and mailing address of the Company's initial principal office shall be 545 Brent Lane, Pensacola, Florida 32503. The Company's principal office may hereafter be at such other place or places as the members from time to time may determine. The name of the initial registered agent of the Company shall be Richard M. Rocha and the street address of the registered agent is 3128 West Kennedy Boulevard, Tampa, Florida 33609.

ARTICLE V (MANAGEMENT)

The Company will have a manager and should be considered a manager-managed company. Until the first annual meeting of members or until the manager's successors are elected and qualified, the initial manager's name is:

The Company shall not be dissolved but instead shall continue notwithstanding the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event terminating membership in the Company: however, in any such event, a majority in interest of the remaining members (of such greater percentage as may be specified from time to time in the Company's Operating Agreement or regulations) shall have the right upon the occurrence of any such event to elect to dissolve the Company.

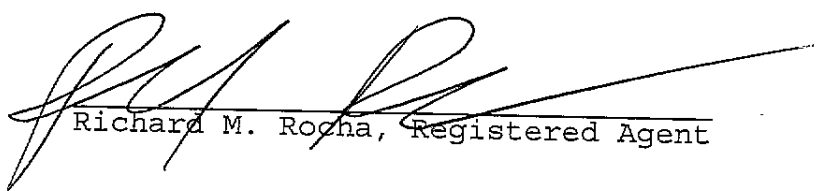
