**Articles of Organization
for
InfoWorks Research, Design & Development, L.C.**

The undersigned persons acting as an organizers and authorized representatives of a limited liability company under the Florida Limited Liability Company Act (referred to hereafter as "The Act") adopts the following Articles of Organization (referred to hereafter as "Articles")

1. **Name.** The name of the limited liability company is **InfoWorks Research, Design & Development, L.C.** (referred to hereafter as "The Company").
2. **Principal Place of Business.** The mailing address of The Company is: 1923 Chuli Nene, Tallahassee, Florida 32301, and the address of its principal place of business is:

3. **Duration.** The existence of the Company shall commence July 1, 2000, and its period of duration is perpetual, unless dissolved by the members or as provided for by Florida law.
4. **Purpose.** The purpose for which The Company is organized is to conduct any business activities authorized by The Act, and to do any and all things necessary, convenient, or incidental to that purpose.
5. **Registered Agent & Office.** The name of The Company's registered agent whose "Consent to Appointment as Registered Agent" is included with these Articles, is Robin Colson, and the address of The Company's Registered Office is:

Tallahassee, FL 32301

6. **Additional Capital Contribution of Members.** Capital contributions in addition to the initial capital contributed by the members at formation of The Company shall be required in accordance with The Company's Operating Agreement.
7. **Admission of Additional Members.** Additional members may be admitted only upon such terms as are unanimously agreed to by all members pursuant to provisions in the Operating Agreement.
8. **Continuity.** The members of The Company have the right to continue the business upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or occurrence of any other event which terminates the continued membership of a member in The Company. Continuation may occur only pursuant to the terms of the Operating Agreement and with the unanimous vote of the members.
9. **Return of Capital and Distribution of Profits.** The members' right to a return of capital shall be determined from The Company's books, as of the effective date for an interim distribution sale of property or termination of The Company, when generally accepted accounting practices permit a return without jeopardizing The Company's financial solvency. Unless a different allocation is determined by unanimous agreement of the members, income and surplus will be shared by the members according to the percentage of their ownership in The Company.
10. **Membership Stipulation.** Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company. The terms by which a member withdraws from The Company are subject unanimous agreement, specified in the Operating Agreement and otherwise subject to the limitations imposed by Florida law. A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous consent of all members.

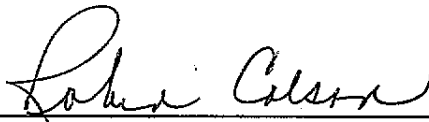

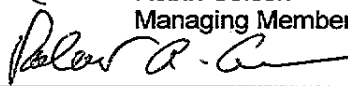
11. **Management.** The business of The Company shall be managed by its members. The member-managers shall vote according to the proportionate capital interest in The Company and shall have exclusive authority to act for The Company in all matters, unless otherwise provided in the Operating Agreement.
