# ARTICLES OF ORGANIZATION OF dingo dub more productions, LLC

These Articles of Organization are executed and filed with the Florida Department of State to form a limited liability company pursuant to the Florida Limited Liability Company Act (the "Act"):

#### ARTICLE L NAME

The name of the limited liability company is: dingo dub more productions, LLC.

#### ARTICLE II. ADDRESS

The mailing and street address of the principal office of the limited liability company is 4010 Knights Ave., Tampa, Florida 33611.

## ARTICLE III. MANAGEMENT OF COMPANY

The business of the limited liability company will be managed by managers who will be elected by the members of the limited liability company in the manner set forth in its Operating Agreement. The managers have the power and authority, to the exclusion of the members, to manage the affairs and business of the limited liability company and will hold the offices and have the responsibilities that are conferred on them in the Operating Agreement of the limited liability company. A member of the limited liability company does not have any authority to incur any contractual liability or obligation on behalf of the limited liability company, unless the member is a manager of the limited liability company.

#### ARTICLE IV. PURPOSE, POWERS, AND AUTHORITY

The limited liability company is organized for all lawful purposes, except banking and insurance. In furtherance of its purpose, the limited liability company has full power and authority to do all acts and things authorized by law to carry out its affairs and business, including without limitation the power and authority to do everything described in section 608.40% of the Act.
