FIRST: The name of the Limited Liability Company is BLACKROCK RETAIL PROPERTY ADVISORS, LLC.

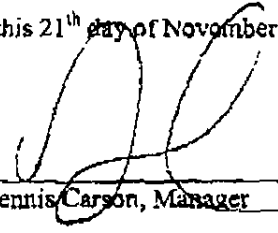
SECOND: The date of filing of the Articles of Organization was June 23, 2000.
