**ARTICLES OF ORGANIZATION  
OF  
KATALYX TRANSPORTATION, LLC**

**ARTICLE I**

The name of the limited liability company (hereinafter called the "limited liability company") is KATALYX TRANSPORTATION, LLC.

**ARTICLE II**
