**ARTICLES OF ORGANIZATION
OF
KATALYX CONSTRUCTION, LLC**

ARTICLE I

The name of the limited liability company (hereinafter called the "limited liability company") is KATALYX CONSTRUCTION, LLC.

ARTICLE II
