ARTICLES OF ORGANIZATION**

The undersigned being a duly authorized representative of a Member and acting as organizer of a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the Limited Liability Company shall be Dynamic LLC.

ARTICLE II. DURATION

The period of the Company's duration shall commence at 12:01 a.m. on June 28, 2000 and shall exist perpetually, unless terminated (i) in accordance with the Company's Operating Agreement, (ii) by the unanimous written agreement of all Members, (iii) by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or (iv) upon the occurrence of any other event which terminates the continued membership of a Member. Upon any such termination event, however, the existence and business of the Company may be continued with the consent of all the remaining Members of the Company, or by amendment of these Articles of Organization providing for the continued existence of the Company.

ARTICLE III. PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE VII. MANAGEMENT

The business of the Company shall be conducted, carried on, and managed by no fewer than one (1) Manager, who shall be elected annually by the Members of the Company in the manner prescribed by and provided in the Operating Agreement of the Company. The Managers shall have the right and responsibilities accorded them as more particularly described in the Operating Agreement of the Company. ARTICLE VIII. AMENDMENT OF REGULATIONS


The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company.
