This limited liability company shall indemnify its members to the full extent permitted by the laws of the State of Florida.

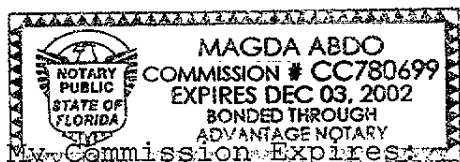
