10-29-00.

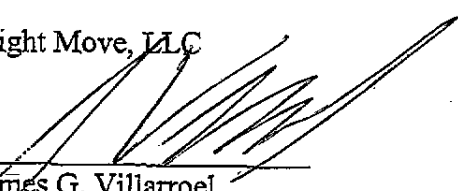
Second: The following amendment to the articles of organization was adopted by the limited liability company:
