The undersigned for the purpose of forming a professional limited liability company under the laws of Florida, adopts the following Articles of Organization:

**ARTICLE I**  
**NAME/PURPOSE**

The name of the professional limited liability company is **STAR MEDICAL GROUP, P.L.** The purpose of the professional limited liability company is to engage in the practice of medicine and to render medical services in the state of Florida.

**ARTICLE II**  
**ADDRESS**

The mailing address of the principal office of the limited liability company is 1205 Monument Road, Jacksonville, Florida 32225 and the street address is 1205 Monument Road, Jacksonville, Florida 32225.

**ARTICLE III**  
**DURATION**

The period of duration for the limited liability company shall be for a term of forty (40) years, unless sooner terminated and dissolved in accordance with the Regulations. Company existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of Florida within five (5) days, exclusive of legal holidays, after they are executed and acknowledged, the company existence shall commence upon filing by the Department of State.

**MEMBERS RIGHTS TO CONTINUE BUSINESS**

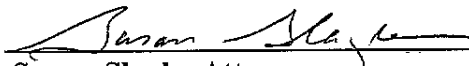

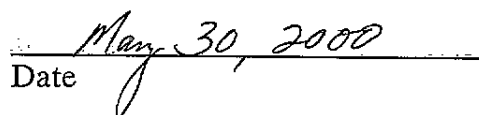
