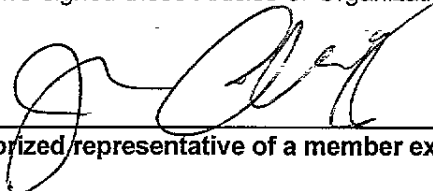
ARTICLE VII Member's Rights to Continue Business:

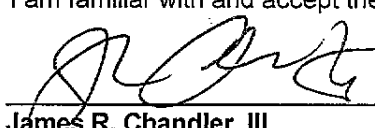
