**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION OF
RICHLAND MISSOURI CITY, LLC**

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **RICHLAND MISSOURI CITY, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Limited Liability Company Act, as amended *Florida Statutes* § 608.411:

1. Name of Company. The name of the Company is **RICHLAND MISSOURI CITY, LLC**.

2. Date of Filing of Articles of Organization. The Company filed its Articles of Organization (the "Articles") with the Florida Department of State on June 29, 2000.

3. Amendments to Articles of Organization.

a. Paragraph 1 of the Company's Articles is hereby amended by deleting the current text of Paragraph 1 in its entirety and substituting the following new Paragraph 1 in lieu thereof:

*"1. Name. The name of this limited liability company is **RICHLAND TOWERS - MISSOURI CITY, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida."*

b. Paragraph 7 of the Company's Articles is hereby amended by deleting the current text of Paragraph 7 in its entirety and substituting the following new Paragraph 7 in lieu thereof:


"2. Management of the Company. The management of the Company shall be vested in the managers of the Company."
