ARTICLES OF ORGANIZATION OF FAST TRACK REHABILITATION, LLC

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I — Name:

The name of the Limited Liability Company is: Fast Track Rehabilitation, LLC (hereinafter the "Company").

ARTICLE II — Address:
