**ARTICLES OF ORGANIZATION
OF
RK INVESTMENTS, LLC**

The undersigned hereby certifies that the Members have associated together for the purpose of becoming a Limited Liability Company under Florida Statutes Chapters 608, providing for the formation, rights, privileges, and immunities of limited liability companies for profit and the following Articles of Organization are hereby adopted.

**ARTICLE I.
NAME**

The name of the Limited Liability Company shall be RK INVESTMENTS, LLC.

**ARTICLE II.
DURATION; EFFECTIVE DATE**

This Limited Liability Company shall exist perpetually, commencing as of the date on which these Articles of Organization are filed with the State of Florida Department of State.

**ARTICLE III.
ADDRESS; PRINCIPAL OFFICE**

The mailing address of the Limited Liability Company and the street address of the principal office Limited Liability Company is 1205 Parilla De Avila, Tampa, FL 33613.

**ARTICLE IV.
INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

The address of the initial registered office of the Limited Liability Company is 1205 Parilla De Avila, Tampa, FL 33613, and the name of its initial registered agent at such address is Randall W. Krafft.

**ARTICLE V.
PURPOSE**

This Limited Liability Company may engage in any activity or business permitted under the laws of the United States of America and of this State.

**ARTICLE VI.
RESTRICTIONS ON TRANSFER OF MEMBERSHIP;
RIGHT TO ADMIT ADDITIONAL MEMBERS**

A Member's interest in the Limited Liability Company shall not be sold or otherwise transferred except with the written consent of a Managing Member of the Limited Liability Company and otherwise in accordance with the Operating Agreement of the Limited Liability Company.

Admission of new Members requires the vote of the Managing Member of the Limited Liability Company. Contributions required of new Members shall be determined as of the time of admission to the Limited Liability Company in accordance with the Operating Agreement of this Limited Liability Company.

The ownership interests and voting rights and interests of the Members shall be determined in accordance with the Operating Agreement of this Limited Liability Company.

**ARTICLE VII.
CONTINUATION**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or the occurrence of any other event that terminates the continued membership of a Member in the Limited Liability Company, the remaining Members shall have the right to continue the business upon affirmative vote of a majority of the remaining Members who hold voting interests.

**ARTICLE VIII.
MANAGEMENT**

Management of the Limited Liability Company is reserved to its Managing Member in accordance with the Operating Agreement of this Limited Liability Company. The name of the Managing Member is as follows: Randall W. Krafft, Trustee of the Randall W. Krafft Family Trust dated August 21, 1992, Randall W. Krafft, Settlor and Trustee. The address of the Managing Member is 1205 Parilla De Avila, Tampa, FL 33613.

**ARTICLE IX.
OPERATING AGREEMENT**

The Voting Members of the Limited Liability Company shall have the power to adopt, alter, amend, or repeal the Operating Agreement which may contain any provisions for the regulation and management

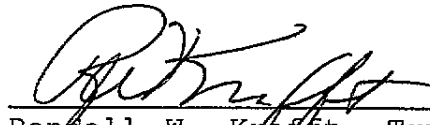
of the affairs of the Limited Liability Company that are not inconsistent with applicable law or these Articles of Organization.
