ARTICLES OF ORGANIZATION

OF

a Florida limited liability company

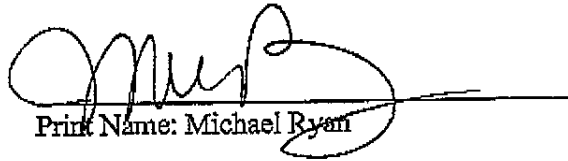
