ARTICLES OF ORGANIZATION OF MALIBU LODGING INVESTMENTS, LLC

THE UNDERSIGNED, the initial member of MALIBU LODGING INVESTMENTS, LLC, a Florida limited liability company formed hereunder (the "Company"), hereby forms a limited liability company under the laws of the State of Florida.

ARTICLE I. COMPANY NAME

ARTICLE VI. ADMISSION OF ADDITIONAL MEMBERS

Pursuant to Section 608.4232 of the Act, the Company may admit additional members upon the affirmative vote of a majority of those managers of the Company in attendance at a duly called meeting of the managers at which a quorum exists or by written consent of a majority of the managers of the Company. ARTICLE VIII. DISSOLUTION OF COMPANY
