# ARTICLES OF ORGANIZATION OF ELECTRONIC SAVINGS & PRIZES LLC

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

### ARTICLE I. NAME
