## ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION

OF

## NIMBUS ENTERPRISES, L.L.C.

Pursuant to the provisions of the Florida General Corporation Act, the undersigned limited liability company adopts the following Articles of Amendment to its Articles of Organization:

- 1. The name of the limited liability company is NIMBUS ENTERPRISES, L.L.C. and the original date of filing/authorization in Florida was June 28, 2000 (Document Number: L00000007904).
- 2. The following amendment of the Articles of Organization was adopted by the unit holders and managing members of the limited liability company on the 1<sup>st</sup> day of January, 2005, in the manner prescribed by the Florida General Corporation Act:

Article IV is amended by changing the number of the number of managers who shall manager-manage the limited liability company from "one (1) manager" to "two (2) managers", so that Article IV shall now read:
