**ARTICLES OF ORGANIZATION OF JAYCO, LLC  
A LIMITED LIABILITY COMPANY**

The undersigned, desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

**FIRST:** The name of said limited liability company shall be JAYCO, LLC and the mailing address and the street address of the principal office of the limited liability company shall be: 19701 Country Club Drive, East, # 201 Aventura, Florida 33180.

**SECOND:** JAYCO, LLC shall have a perpetual duration from the date of the filing of these Articles of Organization.

**THIRD:** Copies of the operating agreement and bylaws of JAYCO, LLC may be obtained from the Managing Member via a written request mailed to: 19701 Country Club Drive, East # 201, Aventura, Florida 33180, which is the place in the State of Florida where the principal office of the company is located.

**FOURTH:** The purposes for which the JAYCO, LLC is formed are:

- (A) The purchase, sale, marketing, advertising, and production and/or development of real estate ventures, income-production property, franchises and any other businesses in the State of Florida or elsewhere.
