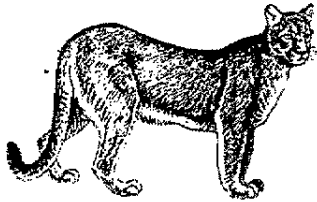

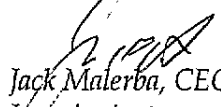

# **Articles of Amendment to the Articles of Organization For South End Studios, L.L.C.**

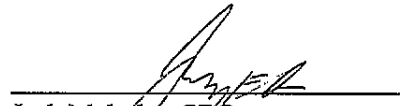
### **Article 4 – Registered Agent and Registered Office**

**Article 5—Management**

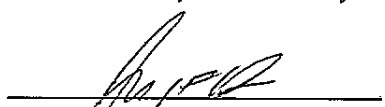
This limited liability company is member-managed.
