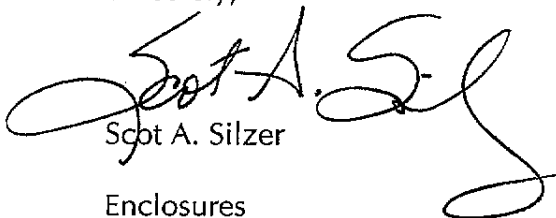

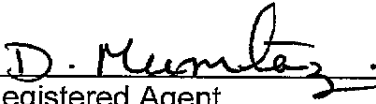
**ARTICLE III. MEMBERS**

#### **ARTICLE V. POWER AND AUTHORITY**

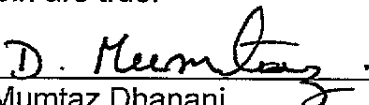
The Limited Liability Company shall have all the rights and powers now or hereafter conferred on Limited Liability Companies by the laws of the State of Florida.
