ARTICLES OF ORGANIZATION

OF

CUNNINGHAM-ASHBY , LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Act (Florida Statutes, Chapter 608).

Article 1. Name

The name of this limited liability company is CUNNINGHAM-ASHBY , LLC (the "Company").

Article 2. Duration

The Company shall exist perpetually from the date of filing these Articles with the Department of State until the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by the unanimous consent of all of the remaining members.

Article 3. Address

The Company's mailing address and the street address of the Company's principal office is 13131 University Drive Fort Myers, Florida 33907.

Article 4. Registered Agent and Office

The name of the Company's initial registered agent is Anthony J. Gargano. The street address of the Company's initial registered agent is 2075 West First Street, Suite 203, Fort Myers, Florida 33901.

Article 5. Additional Members

Additional members may be admitted to the Company, but only if all of the current members agree to the admission of the additional member and to the terms of the additional member's admission.

Article 6. Termination of Membership

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member of a membership in the Company, the remaining

members may, by unanimous written agreement, continue the business of the Company.

Article 7. Management of the Company

The Company shall be managed by one manager and is therefore a manager-managed company. The management of the Company is reserved to Stephen A. Cunningham, the managing member.

Article 8. Regulations

The members shall have the power to adopt, alter, amend, or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.

Article 9. Date of Existence of the Company

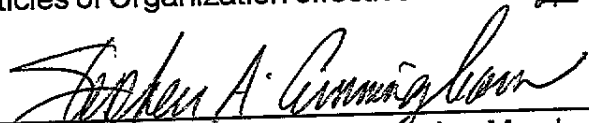
The existence of the Company shall commence on the date of filing the Articles of Organization with the Florida Department of State.

Article 10. Indemnification

The Company shall indemnify each member, the managing member, and the registered agent including former members, managing members, and registered agents to the full extent permitted by law.

In accordance with section 608.408(3), Florida Statutes, the execution of this document constitutes an affirmation under the penalties of perjury that the facts stated herein are true.

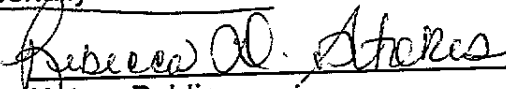
