TO  
ARTICLES OF ORGANIZATION

**Article 1. Name**

2. Article 4 is amended to read as follows:

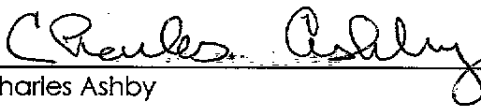
