**ARTICLES OF ORGANIZATION FOR

The undersigned member, acting as an organizer of a limited liability company under the Florida Limited Liability Company Act, F. S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization:

**ARTICLE I - NAME**

The name of the Limited Liability Company (hereinafter the "Company") shall be:

**ARTICLE II - DURATION**

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is dissolved earlier by the unanimous written agreement of all members of the Company or as provided in these Articles of Organization.

## **ARTICLE VI - MEMBERS' RIGHT TO CONTINUE BUSINESS**

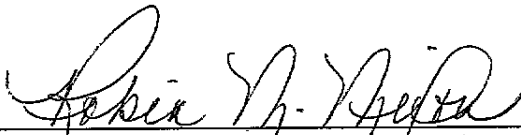

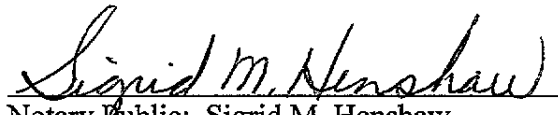

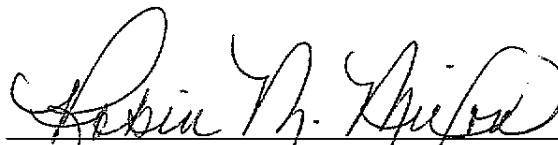
