# LAKE IDA & JOG, LLC ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provision of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

#### ARTICLE I - NAME

The name of the Limited Liability Company is "Lake Ida & Jog, LLC"


