**ARTICLES OF ORGANIZATION**

**OF**

**LENHARDT AND WICKHAM, LC**

For the purpose of organizing a Limited Liability Company, pursuant to Chapter 608, Florida Statutes, the undersigned submits the following Articles of Organization:

1. The name of the Limited Liability Company shall be Lenhardt and Wickham, LC.

2. The duration of the Limited Liability Company shall be perpetual.

3. The mailing address and street address of the principal office of the Limited Liability Company is 301 Valencia Court, Winter Garden, Florida 34787.

4. The initial Registered Agent of the Limited Liability Company is Patrick M. Magill, Esquire, whose address is 2110 East Robinson Street, Orlando, Florida 32803.

5. The initial members of the Limited Liability Company are:

Additional members may be admitted to the Limited Liability Company, only upon the unanimous consent of the existing members.

6. In the event of the death, retirement, resignation, expulsion, or bankruptcy (defined as the filing of any Petition for Bankruptcy in the appropriate court of jurisdiction, either voluntary or involuntary) of a member, the remaining member or members of the Limited Liability Company shall have the right to continue the operation of the business and of the Limited Liability Company. A member may be expelled only

upon the unanimous consent of every other member, and in no event shall take place as a result of the vote of fewer than two (2) members of the Limited Liability Company.

7. The management of the Limited Liability Company is reserved to the members, upon majority vote. The members are empowered, nevertheless, to appoint agents or officers of the Limited Liability Company, who will have the powers enumerated to them by a resolution of the members to that effect. - By Joyce Lenhardt, equipment and materials, and the license for certain patents held by her or by Theodore Lenhardt, valued at \$30,000.00.




**ACCEPTANCE BY REGISTERED AGENT**
