<u>SCHEDULE A</u>

ARTICLE III -- DURATION

The duration of the limited liability company shall be perpetual.

ARTICLE VII -- ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the required written consent of members of the company holding at least 51% of the units of the company and on such terms and conditions as shall be determined by the members or regulations. All members must become a party to the Limited Liability Company Agreement which outlines the rules and regulations of the company. A member may transfer his or her interest in the company as set forth in the Limited Liability Agreement or other such regulations of the company, but the transferee shall have no right to participate in the agreement or other such regulations of the company, but the transferee shall have no right to participate in the management of the business affairs of the company or become a member unless the requisite members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by vote of the remaining members holding at least 51% of the remaining units.
