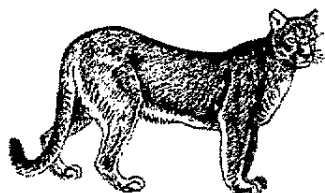



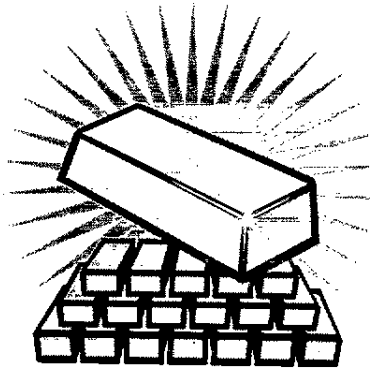

The limited liability company shall engage in an entertainment business or any business permitted under Florida Limited Liability Company Act.


Article 4 – Registered Agent and Registered Office

Article 8—Management


