ARTICLES OF ORGANIZATION

ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

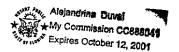
The company shall not be dissolved on the death, bankruptcy, or dissolution of a member or manager, but shall be dissolved as is set forth in the regulations.
