**ARTICLES OF ORGANIZATION
OF
MEESTER MARINE RESOURCE CONSULTING, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **MEESTER MARINE RESOURCE CONSULTING, LLC** ("company").

ARTICLE II -- ADDRESS


ARTICLE VI -- MEMBERS' RIGHT TO CONTINUE BUSINESS

ARTICLE IX -- MANAGEMENT



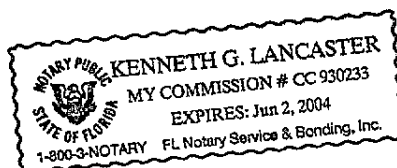


