ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I

The name of the Limited Liability Company shall be **PALMS WEST MRI, L.L.C.**, (the "Company").


