**ARTICLES OF ORGANIZATION  
OF  
CHECKCANCER.COM, L.L.C.**

1. **Name.** The name of this limited liability company is CHECKCANCER.COM, L.L.C., a Florida limited liability company (the "Company").

2. **Duration.** The Company shall have perpetual existence, commencing upon the date of filing of these Articles of Organization with the Florida Department of State, unless these Articles of Organization or the operating agreement of the Company provides otherwise.

3. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. **Place of Business.** The mailing and street address of the Company's principal office is 3001 W. Dr. Martin Luther King, Jr. Boulevard, Tampa, Florida 33607.

5. **Registered Agent and Office.** The name of the initial registered agent of the Company is Joseph W.N. Rugg. The street address of the initial registered agent of the Company is Akerman, Senterfitt & Eidson, P.A., 100 S. Ashley Drive, Tampa, Florida 33602.

6. **Contributions to the Company.** No cash or property (other than cash) has been contributed to the Company by the members. No additional contributions have been agreed upon.

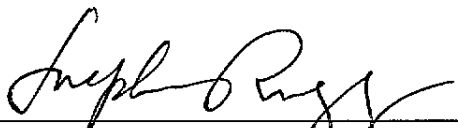
7. **Additional Members.** Additional members to the Company may be admitted, but only upon the consent of the Managers of the Company at the time admission is sought.

8. **Termination of Membership.** Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless all remaining members agree in writing to continue the business of the Company.

9. **Management of the Company.** The Company shall be managed by a manager or managers in accordance with the operating agreement adopted by all of the members. The Company shall initially be managed by S. Aaron Laden, M.D., 3001 W. Dr. Martin Luther King, Jr. Boulevard, Tampa, Florida 33607, who shall serve as the manager until the first annual meeting of the members or until his successor or successors are elected and qualified.

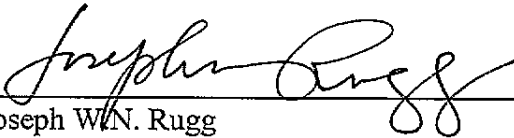
