ARTICLES OF ORGANIZATION
OF
FIRST WORLDWIDE MARINE SERVICES, L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be FIRST WORLDWIDE MARINE SERVICES, L.C.

ARTICLE II - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall terminate not later than seventy five (75) years from the date that these Articles of Organization are filed with the Florida Department of State, unless the Company is earlier dissolved as provided in these Articles of Organization, the operating agreement, or as provided in Chapter 608, Florida Statutes (1999).

ARTICLE III - MAILING ADDRESS AND STREET ADDRESS

The initial mailing address and the initial street address of the Company is 1859 S.W. Place, Miami, FL 33175.

ARTICLE IV - REGISTERED OFFICE AND AGENT

The name and street address of the initial registered agent of the Company in the State of Florida is WILLIAM WATSON TRICK, JR., at 1216 East Atlantic Blvd., Pompano Beach, FL, 33060.

ARTICLE V - ADMISSION OF ADDITIONAL MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members, or as is otherwise set forth in the operating agreement of the Company. A member may transfer his or her interest in the Company as set forth in the operating agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the

Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VI - DISSOLUTION AND MEMBERS RIGHTS TO CONTINUE BUSINESS

The Company shall be dissolved at the expiration of its existence as provided hereinabove, as may be provided in the operating agreement of the Company, or as is otherwise provided by Chapter 608, Florida Statutes (1999). The rights of the members to continue business shall be as provided in the operating agreement, or as is otherwise provided by Chapter 608, Florida Statutes (1999).


ARTICLE VII - MANAGEMENT

The Company shall be managed by the members in accordance with the operating agreement.


ARTICLE VIII - PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful business which a limited liability company may transact by law. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.
