ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF SUNSHINE MEDICAL PLAZA, LLC

FIRST: The date of filing the Articles of Organization was July 18, 2000.

SECOND: The following amendment to the Articles of Organization of the Company were adopted by all of the members of the limited liability company:

1. The following shall be inserted as Article VI, Withdrawal of a Member, in the Articles of Organization:

ARTICLE VI. Withdrawal of a Member

As provided in the Company's Operating Agreement, a Member shall, with the consent of a Majority in Interest, have the right to withdraw from the Company with one hundred twenty (120) days prior written notice to all of the Members. For purposes of the Company's Operating Agreement, the expiration of such one hundred twenty (120) day period shall be deemed to constitute the "Effective Date of Withdrawal." In the event a Member withdraws, with the consent of a Majority in Interest, (the "Withdrawing Member"), the Withdrawing Member shall not be entitled to receive, within a reasonable time after withdrawal, the "fair value," within the meaning of Section 608.472(2) of the Act, of the Withdrawing Member's Company Interest as of the date of resignation based upon the Withdrawing Member's right to share in distributions from the Company or otherwise. Instead, the Company shall, with the consent of a Majority in Interest, purchase, and the Withdrawing Member shall sell, all (but not less than all) of the Company Interest owned by the Withdrawing Member (the "Withdrawing Member's Company Interest") for a purchase price and upon the terms described in Sections 8.12, 8.13 and 8.14 of the Company's Operating Agreement.

THIRD: The effective date of these Articles of Amendment shall be upon the filing thereof with the Florida Department of State.
