ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of a member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is UIP ADVISORS, LLC (the "Company").

The business of the Company shall be conducted, carried on, and managed by a Manager or Managers, who shall be elected annually by the Members of the

Company in the manner prescribed by and provided in the Operating Agreement of Such Manager or Managers shall also have the rights and the Company. responsibilities described in the Operating Agreement of the Company.

ARTICLE VIII. OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company.
