**ARTICLES OF ORGANIZATION FOR  
FUN SPOT RENTALS, LLC**

**Article I - Name**

The name of the Limited Liability Company is Fun Spot Rentals, LLC.

**Article II - Address**

The mailing address and street address of the principal business office of the Limited Liability Company is 2205 East Tamiami Trail, Naples, Florida 34112.

**Article III - Duration**

The period of duration for the Limited Liability Company shall be twenty (20) years, unless terminated earlier in accordance with the Operating Agreement of the Limited Liability Company.

**Article IV - Management**
