**FIFTH:** All debts, obligations, and liabilities of the Company have been paid or discharged, or adequate provision has been made therefor pursuant to Section 608.4421.


**SIXTH:** All remaining property and assets of the Company have been distributed between its members in accordance with their respective rights and interests.


**SEVENTH:** There are no suits pending against the Company in any court.


