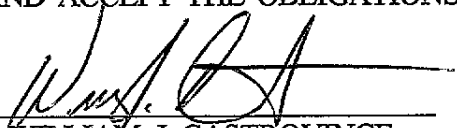

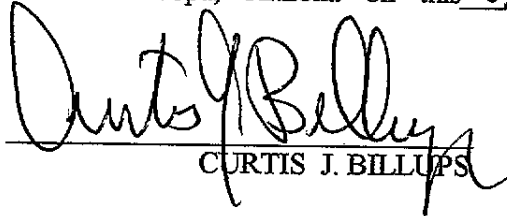
ARTICLE VII
