

5. Duration. The duration of the limited liability company is perpetual.
6. Management. The limited liability company is to be managed by a manager or managers and is, therefore a manager – managed company.
7. Admission of Additional Members. Additional Members may be admitted if each such additional Member agrees to be bound by the Regulations of the limited liability company and the existing Members of the limited liability company at the time the new Member is to be admitted give their unanimous written consent to the admission of each such additional Member.

8. Members Rights to Continue Business. Upon an event of dissociation, the Members of the limited liability company may continue the business of the limited liability company if a majority of the Members holding a majority of the interest in the limited liability company vote in favor of continuing the business of the limited liability company.
9. Regulations. The operation of the limited liability company shall be governed according to the provisions of the Regulations executed by all Members which shall be continuously on file at the registered office.
