ARTICLES OF ORGANIZATION

OF

GATO PROPERTIES, L.L.C.

The undersigned subscribers to these Articles of Organization, each a natural person, competent to contract, hereby associate themselves together to form a limited liability company under the laws of the State of Florida, Florida Statutes 608.401 et. seq., and the company so formed shall be for profit.

ARTICLE I-NAME

The name of the limited liability Company shall be GATO PROPERTIES, L.L.C.

ARTICLE II-TERM OF EXISTENCE

This Limited Liability Company is to exist for a period of ninety-nine (99) years and shall commence at the time of filing these Articles, unless terminated sooner by the unanimous written agreement of all Members or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member or upon the occurrence of any other event which terminated the continued membership of a Member, unless the business is continued by the consent of all the remaining Members, or by Amendment of the Articles of Organization providing for the continued existence of the Company subsequent to the foregoing events.

The general purpose of the business to be transacted by this limited liability Company shall be to purchase, sell, own, hold, lease or otherwise deal in or with real or personal property, wherever situated; and to engage in any activites or business



ARTICLE XI-AMENDMENT TO REGULATIONS
