ARTICLES OF ORGANIZATION

<u>OF</u>

Le Sirenuse, LLC.

A limited Liability Company organized under Chapter 608, Florida Statutes. The undersigned, being one (1) of the initial members of a limited liability company to be formed under the Florida Limited Company Act (the "Act"), hereby adopts these, the following Articles of Organization.

interest of any two of the initial members to less than a majority interest in the percentage of shares of the Company, then such admission must be approved by the unanimous consent of the holders of the percentage shares of interest of the Company.
