**ARTICLES OF ORGANIZATION
OF
LINDA AND DAVID MENG, LLC**

The undersigned Organizers of a limited liability company organized under the Florida Limited Liability Company Act does hereby adopt the following Articles of Organization for such limited liability company.

**ARTICLE I
NAME OF THE LIMITED LIABILITY COMPANY**

The name of the limited liability company shall be Linda and David Meng, LLC.

**ARTICLE II
ADDRESS**

**ARTICLE VI
MANAGEMENT**
