ARTICLES OF ORGANIZATION OF NEW MILLENNIUM CAPITAL GROUP, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I NAME

The name of the limited liability company shall be New Millennium Capital Group, L.L.C. ("Company").

ARTICLE II PURPOSE AND POWER

No oral agreement among any of the members or managers of the Company shall be deemed or construed to constitute any portion of, or otherwise affect the interpretation of, the Operating Agreement of the Company, as amended and in existence from time to time.
